#### DESCRIPTION

#### DIRECTIONS FOR USE

Shake before and occasionally during use. Always test on a small area first. Spray directly on surface to

be cleaned and allow to penetrate briefly. Wipe off with a clean damp cloth and dry. For more difficult jobs, apply generous amount of cleaner and allow to stand for a few minutes before wiping dry. For extremely tough jobs, scrub with a nylon brush or scouring pad and wash with a wet rag and dry. Repeat as needed.

**Note:** Do not use on hot or even warm surfaces. Let surface cool to ambient temperature before cleaning. Do not dilute product.

#### CAUTIONS

**Keep out of reach of children.** Eye irritant. Avoid contact with eyes, mucous membranes and prolonged contact with skin. Rubber gloves are recommended for sensitive skin.

Do not mix this product with any other chemicals or cleaners. Do not use with chlorine bleach.

#### FIRST AID
